

CONSIGNMENT AGREEMENT WITH PLENTY OF POSH LLC

Please read carefully; we do not want to waste your time & energy bringing items in that do not fit our policies.

1. **A ONE TIME \$10.00 account set up fee is required from all new consignors regardless of quantity consigned. This will be waived if you chose to donate all unused/unsold items.** Payments are processed & mailed the first week of each month for monies earned the full previous month. Balances under \$5 will be carried to the next month.
2. Consignment items are accepted on Wednesdays & Saturdays with a limit of 15 pieces each week. Please watch the store postings for any special notice of change due to holidays. Clothing is consigned for 90 days and may be renewed ONCE. *Consignments are NOT accepted during the months of February and July.*
3. **All clothing, shoes and accessories must be in gently used condition and currently in style.** Must be recently washed, no fading, holes, (unless manufactured that way) missing buttons or other parts, stains or odors. We reserve the right to refuse clothing that smells of smoke or any other unsavory scent or contains animal hair. Items later noticed to be in need of repair or cleaning may, without notice, be donated/disposed of properly. Please do not be offended if we do not take all you bring in. Everyone has different judgment, but we will have the final say. We strive to offer the latest fashions with quality, brand and price. Not all garments brought in may fit our store direction or target market. **All must have brand AND size labels so we can tag appropriately.**
4. We do not accept "knock off or designer inspired" purses and/or accessories. We will consign and sell only authentic designer purses & accessories.
5. We do not accept clothing from K-Mart, Shopko, Wal-mart, or Sam's Club. Target and Old Navy items will be taken on an item by item determination only as some are trendy & fashionable but the quality may be questionable.
6. A selling price will be determined by Plenty of Posh based on brand, quality, demand and economic conditions within our target area of Rock County. Fifty percent (50%) of the selling price of each consigned item shall be retained by Plenty of Posh and Fifty percent (50%) shall be payable to the Consignor. Plenty of Posh will try and sell your items at the best possible price, however at the discretion of Plenty of Posh, all items are subject to be reduced by 30-50% during the consignment period & participate in store promotional discounts. It is also the determination of Plenty of Posh as to how the merchandise will be displayed or marketed.
7. Consignor must pick up all unsold items within five (5) business days from the end date of consignment or renew for another 90 days. All unsold items not picked up after the end of the contract period will, WITHOUT FURTHER NOTICE, automatically become property of Plenty of Posh.
8. Plenty of Posh takes every effort to avoid damage or theft, however, we can not be responsible for any merchandise that is stolen or damaged, including but not limited to fire or flood.
9. To avoid extra unnecessary work, we ask that you abide by leaving your items for 90 days. Early pulling of your unsold items will be allowed once – for which you will need to give 24 hrs notice – and you will be responsible for pulling the items from the floor. Continuing to pull your items early may subject your account to consignment termination.
